TENTATIVE ANNUAL TAX LEVY ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR 2025 OF THE VILLAGE OF INDIANOLA, VERMILION COUNTY, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Village of Indianola, Vermilion County, Illinois, in meeting assembled, as follows:

Section 1. Findings and Declaration

The President and Board of Trustees find and declare that it is necessary to raise by taxation the amounts hereinafter set forth, to be levied upon all taxable property in the Village of Indianola, in order to meet and defray all necessary expenses and liabilities of the Village as required by statute or as otherwise authorized by law.

Section 2. Tax Levy

The amounts to be levied for the year 2025 are itemized as follows:
